Application for approval of reserved matters including Access, Layout, Scale, Appearance and Landscaping following outline planning application 1832/17 Allowed at Appeal APP/W3520/W/18/3200941 for residential development for up to 190 dwellings (Use Class C3) with public open space, vehicular access and associated infrastructure.

Land West Of Old Norwich Road Whitton Ipswich Suffolk IP1 6LQ

The Parish Council have received emails from residents regarding this proposal. Two existing houses have water in their foundations and have concerns about the development contributing to excess water. One resident highlighted that the archaeological survey of the site required a further independent dig. It appears that Bellway intend to self-monitor as they build and this is not acceptable. Bus stops on the plan do not correspond with the appeal documentation. Plot one overshadows an existing property.

Councillors requested comments on the archaeological dig, the roundabout, the position and size of plot one, the bus stop raised curbs, enforcement of no through road and issues of congestion on access to A14 for Whitton residents.

PL-11-20-08. Joint Local Plan

Councillors noted and discussed the Joint Local Plan. Councillors agreed that there were many positive points to the plan, but noted that the Barham Church Lane development is included as part of the plan.

Councillors agreed that local consultation regarding developments is essential.

Councillors discussed the potential use of the allotments for access to the A14 bank. The clerk was asked to alert allotment holders that this would be likely.

Cllr Studd will negotiate with Highways regarding further clearance near the allotments and repair of the fence.

Councillors discussed the Masons Landfill Solar Panels consultation and decided that they had no objections to this.

Highways England contacted the Parish Council regarding A14 concrete repair and maintenance between junctions 52 and 55. Councillors noted the correspondence.

A member of the public suggested potential tree planting areas in Claydon, which could possibly be considered in future meetings.
